THE EXECUTIVE COMMITTEE SHALL: 1) TRANSACT THE BUSINESS OF THE CORPORATION BETWEEN MEETINGS OF THE BOARD; 2) FUNCTION AS THE FINANCE, PERSONNEL AND OPERATIONS COMMITTEES, AND REVIEW SUCH OPERATIONS; 3) RECEIVE REPORTS FROM ALL STANDING SPECIAL COMMITTEES, AND, WHEN NECESSARY, DETERMINE ACTION TO BE TAKEN UPON RECOMMENDATIONS SUBMITTED; 4) AUTHORIZE DISBURSEMENT OF FUNDS FOR ALL EXTRAORDINARY EXPENSES; 6) CREATE A SPECIAL COMMITTEE WHEN NECESSARY TO CARRY OUT A SPECIFIC TASK WHICH DOES NOT FALL WITHIN THE RESPONSIBILITY OF ANY STANDING COMMITTEE; 7) MEET WHEN CALLED BY THE CHAIR UPON THREE (3) DAYS TELEPHONE OR WRITTEN NOTICE, PROVIDED, HOWEVER, THAT ANY ACTION WHICH THE EXECUTIVE COMMITTEE IS AUTHORIZED TO TAKE SHALL BE VALID IF EACH MEMBER OF THE COMMITTEE VERBALLY AGREES TO IT, WHETHER IN PERSON OR BY TELEPHONE. EACH SUCH NOTICE OF A SPECIAL MEETING SHALL SPECIFY THE BUSINESS TO BE TRANSACTED; 8) REPORT TO THE BOARD THE BUSINESS TRANSACTED BY THE EXECUTIVE COMMITTEE SINCE THE PREVIOUS MEETING OF THE BOARD; AND 9) ENGAGE THE SERVICE OF CERTIFIED PUBLIC ACCOUNTANTS TO EXAMINE THE FINANCIAL STATEMENTS OF THE CORPORATIONS AT THE END OF EACH FISCAL YEAR.
